**O R D E R**  
**27-1-2017**

The petitioner Sri Joydeb Das is present. The public authority is represented by :- (1) Sri Ramesh Ch. Medhi, SPIO and Managar, (Production), Assam Seeds Corporation Ltd. , and (2) Sri Mainul Haque Talukdar, ASPIO, Assam Seeds Corporation Ltd.

The complaint petition dated 30-11-2016 filed by the petitioner complaining about non-compliance of this Commission's earlier order dated 28-9-2016 by the SPIO of Assam Seeds Corporation Ltd. is taken up for hearing in presence of both the parties.

The SPIO submitted that he has not been able to comply with the order dated 28-9-2016 because of non-receipt of the required information from the concerned branches of Assam Seeds Corporation Ltd., namely Marketing branch and Establishment branch. The SPIO could not produce any correspondence or office communication by which he sought the required information from the Marketing branch and Establishment branch. Nor did he report to this Commission about the action taken by him, non-response by the concerned branches and that the informations as ordered by this Commission on 28-9-2016 are yet to be furnished to the petitioner.

In view of the above, the officers in charge of the Establishment branch and Marketing branch will be treated as deemed PIOs under Section 5(5) of the RTI Act, 2005.

Fix 15-2-2017 at 12.00 Noon for personal appearance of the SPIO and both the deemed PIOs with their written submissions explaining as to why penal action under Section 20 of the RTI Act, 2005 shall not be taken against all three of them for not performing their duties under RTI Act, 2005.
