The petitioner Shri Pranjal Sharma is present. The public authority is represented by Shri D.K. Mishra, SPIO & Joint Commissioner, Guwahati Municipal Corporation accompanied by Shri Chittaranjan Dutta, Member Secretary of Ward No.-19, Guwahati Municipal Corporation. The second appeal petition dated 9.3.16 is taken up for hearing in presence of both the parties.

From perusal of the case records it is seen that the petitioner filed an RTI petition dated 13.10.15 before the PIO of Guwahati Municipal Corporation with reference to a letter No. GDD.230/2012/30-A dated 19th August, 2014 from the Guwahati Development Department to the Commissioner of GMC with certain enclosures including the communication from the office of the Prime Minister of India. It is also seen from the case records that on 6.2.16 the Commissioner of GMC and the first appellate authority heard the first appeal petition dated 23.12.15 and directed the Member secretary, Ward Committee, ward No. 19 of GMC to seek the letter mentioned above and furnish the required information to the petitioner. The SPIO of GMC and the Member Secretary of Ward No. 19 have submitted that they could not trace out the above mentioned letter along with enclosures in the office of the GMC. They have been able to procure the copies of those letters from the Guwahati Development Department, Government of Assam, Dispur. The Member Secretary of Ward No. 19 submitted that he will be able to furnish the required information to the petitioner within 3 (three) days from today. This Commission, therefore, directs the Member Secretary, Ward No. 19 to ensure that the sought for information reaches to the petitioner within 7 days from the date of pronouncement of this order, which was pronounced in presence of both the parties.

With the above order the second appeal petition dated 9.3.16 is disposed of.
