The petitioner Shri Utpal Das is present. The public authority is represented by Shri Probin Ch. Bora, Deputy Secretary, P&R.D. Department, Govt. of Assam. The second appeal petition dated 13.7.15 is taken up for hearing in presence of both the parties.

From perusal of the case records it is seen that the petitioner filed an RTI petition dated 7.2.15 before the PIO of P&R.D. Department seeking informations on several points.

From perusal of the RTI petition it is seen that the informations sought for against point No. 2 & point No. 5 are related, but the informations to be furnished will be vast covering the period 15 years and 10 years respectively. This Commission, therefore, directs the PIO and Deputy Secretary of P&RD Department to furnish the scheme-wise allocation and utilization of funds year-wise for the last 10 years to the petitioner within 30 days from the date of receipt of this order.

As regards points No. 3 & 4 relating to implementation of Anamay Achani, the PIO submitted that the Anamay scheme is not implemented by the P&RD Department. This Commission directs the Deputy Secretary, P&RD Department to inform the petitioner within 7 days from today, the concerned authority with whom this information will be available so that the petitioner can file necessary RTI petition to the PIO of the concerned public authority.

Coming to point No. 1 relating to works allotted to M/S Royal Coach India Pvt. Ltd. during the last 10 years, the Deputy Secretary submitted that P&RD Department did not allot any work to this firm during the last 10 years. However, as a matter of abundant precaution, this Commission directs the Deputy Secretary, P&RD Department, Govt. of Assam to re-confirm the facts after due verification and inform the petitioner about the correct position within 15 days from the date of receipt of this order.

With the above order the second appeal petition dated 13.7.15 is disposed of.
