**O R D E R**

13.02.17

Shri Dharani Dhar Deka is present. The public authority to be represented by the SPIO of Gauhati University is absent. However, the Deputy Registrar and PIO of Gauhati University has sent a written submission dated 10.2.17 stating that the petitioner was furnished informations as sought for by him vide his RTI petitions dated 30.9.16 by email as well as through post on 8.2.17. The Deputy Registrar and PIO has mentioned in his WS that the matter was also discussed by him with the petitioner over phone.

The petitioner acknowledged receipt of the email as mentioned by the Deputy Registrar and PIO in his WS, but he submitted that he is not satisfied with the information furnished to him. The petitioner produced before this Commission a copy of the information received by him vide Deputy Registrar and PIO's letter No. GU/PIO/RTI-22/2017 dated 8.2.17. It is seen from the information furnished by the Deputy Registrar that he furnished the list of only five candidates who secured first class with Chemistry Major in the B.Sc. examination held in 2001. By another sheet enclosed with the forwarding letter, the petitioner was informed that number of candidates securing first class with Chemistry Major in 2001 B.Sc. examination was 5 (five) and number of candidates securing second class was 92 (ninety two). The petitioner submitted that his RTI petition dated 30.9.16 means the first 20 candidates who passed the B.Sc. examination in 2001 with Chemistry Major.

This Commission, therefore, directs the Deputy Registrar and PIO also to furnish the list of the first 15 candidates in order of merit who secured second class

with chemistry major in the B.Sc. examination of 2001 of Gauhati University. The informations shall be furnished within 15 days from the date of receipt of this order.

With the above order the second appeal dated 11.1.17 is disposed of.
