O R D E R

The petitioner Sri Bhuban Sinha is present. From the respondents' side :-(1) Sri Nazbul Haque Choudhury, Head Assistant and SPIO, Cachar Zilla Parishad, (2) Sri Nurul Haque Laskar, Accountant , Cachar Zilla Parishad, Silchar , and (4) Monjit Paul Purkayastha, Computer Assistant, DRDA, Cachar , Silchar are present.

The Secretary, Salchakra G.P has sent a written statement in response to a Summon issued by this Commission. In his W/S dated 1-2-2017 he has submitted with supporting medical certificate that he is a heart patient and had undergone open heart surgery. He further stated that he is also a patient of Diabetics and High Blood pressure. Therefore, he could not appear before this Commission today. He further submitted in his W/S that he had taken all necessary initiatives to provide the sought for information to the petitioner and had invited them vide his letter dated 26-7-2016 to come to the G.P office during office hours, inspect relevant documents and take notes and photocopies thereof. The petitioner said that he has not received this letter.

The SPIO of the office of Project Director, DRDA has submitted a separate written statement dated 17-2-2017 enclosing a letter dated 22-11-2016 addressed to the petitioner Sri Bhuban Sinha requesting him to come to the office of DRDA on 28-11-2016 and receive the required documents. But the petitioner did not turn up. The petitioner submitted that he did not receive the communication dated 22-11-2016 from the SPIO of DRDA, Cachar, also.

In view of the above, this Commission passes the following orders:-

1. The SPIO of Project Director, DRDA is directed to hand over the information prepared by him to the petitioner in presence of this Commission today and get it duly acknowledged by the petitioner. Accordingly, the informations to be furnished by P.D, DRDA was handed over and taken over.
2. As regards the informations to be furnished by Secretary, Salchakra G.P, this Commission directs the SPIO and Head Assistant of Cachar Zilla Parishad Sri Nazbul Haque Choudhury to arrange in his presence, inspection

of relevant documents by the petitioner in the office of Secretary, Salchapra G.P. The inspection of documents will commence at 11 A.M and shall conclude before 2 P.M. The petitioner will be allowed to take notes, and photocopies of relevant documents required by him free of cost up to 20 pages and thereafter @ Rs. 2/- for every additional page of photo copy.

3. (i) The petitioner, (ii) Secretary, Salchapra G.P with all relevant records and documents, and (iii) the SPIO of Cachar Zilla Parishad , all are directed to be present at the office of Salchapra G.P on 8th March, 2017. The SPIO of Cachar Zilla Parishad will report on the inspection of records or otherwise to this Commission immediately thereafter.

The above order was pronounced in presence of the petitioner and the SPIO of Cachar Zilla Parishad. **So , no separate notice is necessary. Send a copy of this order to Secretary, Salchapra G.P through the SPIO of Cachar Zilla Parishad by hand.**

With the above order, the second appeal petition dated 9-12-2016 is disposed of.
