The petitioner Sri Pankaj Kr. Das is present. The public authority is represented by:- (1) Smti Krishna Baruah, OSD, RMSA, Assam, (2) Sri Hiranya Prasad Bairagi, District Consultant (RMSA) ,(3) Smti Chandrani Borkotoky, PIO, RMSA, and (4) Smt. Gayatri Naiding, Inspector of Schools, Dima Hasao, Haflong.

The second appeal petition dated 25-11-2016 is taken up for further hearing in pursuance of this Commission's earlier order dated 30-12-2016 in presence of both the parties.

The Mission Director, RMSA, Assam has submitted a written statement dated 15-12-2017 stating that the informations received from the Inspector of Schools of Dima Hasao and Executive Engineer, PWD (Building), Dima Hasao were provided to the petitioner on 9-2-2017 by e-mail. The Mission Director has also mentioned in his written statement the list of informations furnished by him. His written statement is entered into the case records.

The petitioner submitted that he received the e-mail, but was not provided with the work completion certificate in respect of Science exhibition and book fare held in 2012-2014 in Dima Hasao Autonomous Council. He further submitted that provisional work completion certificates in respect of other works mentioned in his RTI petition has also not been furnished to him.

In response to this the OSD of RMSA submitted a separate statement dated 15-2-2017 detailing the practice and procedure followed by RMSA for implementing various works about which the petitioner has sought some informations. She clarified that he has already been furnished the information which were available as per current the practice and procedure. Her W/S is also entered into the case records.

In view of the above, this Commission directs the Registry of this Commission to provide a copy of the written statement dated 15-2-2017 submitted by M.D , RMSA and the written statement dated 15-2-2017 submitted by Smti Krishna Baruah, OSD, RMSA, Assam..

With the above order the second appeal petition dated 25-11-2016 is disposed of
