ORDER

The petitioner Sri Bipin Ch. Thakuria is present. The public authority is represented by :- (1) Sri D. K. Mishra, SPIO, and Joint Commissioner, GMC, and (2) Sri Santanu Das, Associate Planner, GMC

The complaint petition dated 20-12-2016 is taken up for hearing in presence of both the parties.

The gist of the complaint is that the petitioner is yet to receive the information sought for by him vide his RTI petition dated 14-3-2016. He made a written submission today stating that he is still interested in getting the information and prayed for conversion of the complaint petition into a second appeal petition. His prayer is granted and his complaint petition dated 20-12-2016 is taken up for hearing as a second appeal petition.

From perusal of the case records it is seen that the Commissioner and First Appellate Authority of GMC heard the first appeal petition dated 22-8-2016 and directed the PIO to collect a copy of the RTI petition dated 14-3-2016 and process the same for furnishing the required information to the appellant. The PIO of GMC submitted that they could not find the original RTI petition.

In view of the above, this Commission directs the PIO of GMC to inform the petitioner within 15 days from the date of receipt of this order about the total cost of construction of the multi-storied building of "Fancy Bazar Market Complex, GMC" at MM.Road, Guwahati-1 as well as the date of completion of the said building. *Enclose a copy of the RTI petition dated 14-3-2016 along with this order to the PIO of GMC*.

With the above order the second appeal petition dated 20-12-2016 is disposed of.
