ORDER

The petitioner Sri Deben Saikia is absent. The public authority is represented by :- (1) Sri Parag Kr. Kakaty, Addl Deputy Commissioner, Sonitpur, and (2) Sri Prabir Kr. Dutta, ACS, Election Officer, Sonitpur, Tezpur.

The second appeal petition dated 2-11-2016 is taken up for further hearing in pursuance of this Commission's earlier order dated 14-12-2016.

The SPIO and Election Officer of the office of the Deputy Commissioner, Sonitpur, Tezpur submitted a written statement dated 5-1-2017, enclosing their correspondence with the petitioner furnishing the information sought for by him vide RTI petition dated 16-7-2016.

It is seen that vide his letter dated 25-11-2016, the SPIO and Addl. Deputy Commissioner, Sonitpur, District-Tezpur had enclosed a copy of letter No. NRC-53/2015/14/258 dated 16th August, 2016 from Addl. Deputy Commissioner and Nodal Officer, NRC, Sonitpur, Tezpur. The Nodal Officer, NRC's letter dated 16th August, 2016 responded to the RTI petition dated 16-7-2016 stating that Sri Ram Prasad Sarma, Hon'ble M.P – 9-Tezpur HPC did not submit any NRC application in any of the NSKs under Sonitpur District. Hence the information/ documents sought for by the petitioner is not available with the Nodal Officer, NRC, under Deputy Commissioner, Sonitpur District, Tezpur

In his letter dated 16th August, 2016, the ADC and Nodal Officer, NRC, Sonitpur, also furnished the residential address of Sri Ram Prasad Sarma, as recorded at the time of the last Parliamentary election

In compliance with this Commission's order dated 14-12-2016, the SPIO and Election Officer, Tezpur has furnished the same information once again to the petitioner vide letter dated 5-1-2017.

In view of the above, this Commission is of the view that there is no further cause of action , as the concerned SPIO has already furnished the relevant information to the petitioner in response to his RTI petition dated 16-7-2016. Therefore, his second appeal petition dated 2-11-2016 is disposed of.
