The petitioner Sri Apurba Saikia has informed that he will not be able to attend the hearing on 09.01.2017 due to unavoidable circumstances.

The Public Authority is absent without any intimation.

On perusal of the records, it is seen that the petitioner vide his RTI petition dtd. 30.05.2016 had sought for information relating to R.K. Market situated at Devipukhuri Road under the jurisdiction of Tinsukia Municipality Board. Due to non-receipt of the information, he filed his first Appeal petition before the Deputy Commissioner, Tinsukia on 11.08.2016. The Deputy Commissioner, Tinsukia vide letter dtd. 19.09.2016 directed the PIO, office of the Tinsukia Municipality Board to furnish the required information directly to the applicant with intimation to the office of the Deputy Commissioner. The petitioner filed a non-compliance petition before the Deputy Commissioner, Tinsukia on 31.10.2016, but no action therefore was taken by the first Appellate Authority.

The Commission, therefore, remands the matter to the Deputy Commissioner, Tinsukia to dispose of the matter with a speaking order after hearing both the parties within 21 days from the date of receipt of this order.

With the above direction, second Appeal petition dtd. 17.11.2016 is disposed of.
