Shri Biju Pathak, SPIO, Barama College and Dr. Tiken Chandra Das, Principal, Barama College, Barama, Nalbari are present. They have submitted a Written Statement dated 14.02.2017.

A Written Statement dated 27.01.2017 has been received from the First Appellate Authority/Director, Higher Education, Assam.

The Appellant, Shri Dhrubajyoti Talukdar is present. He submitted a W/S dated 18.02.2017.

From the deposition and perusal of the W/Ss and the case record, it is seen that although the Appellant has received most of the information, he had not received a copy of the advertisement regarding the appointment of an Assistant Professor in the College and the photocopy of the lists of the candidates who appeared in an interview and the roster relating to employee (teaching staff) of the College.

The Principal of the said College clarified that a proper roster has been maintained from 2014 and this can be furnished to the Appellant.

In view of the facts brought out above, the Commission hereby orders that the SPIO, O/o the Principal, Boroma College, Boroma, Nalbari shall furnish the remaining information, namely photocopies of the said advertisement and of the roster as maintained by the College, free of cost, within 10 days of receipt of this order.

The Second Appeal is hereby disposed of.
