**O R D E R**

Smt. Karuna Das, PIO, O/o the General Manager, District Industries & Commerce Centre, Golaghat is present along with an assistant. She has submitted a Written Statement dated 18.02.2017.

The Complainant, Smt. Mitalee Kashyap is present.

Perused the case record. It is seen that the Complaint/Appeal was heard and an order issued on 23.09.2016 directing the SPIO to furnish the remaining information in respect of the 7 (seven) RTI Applications submitted by the Appellant to the SPIO broadly on the same subject within 10 days of receipt of the order. The Appellant submitted a Complaint dated 31.10.2016 about non-compliance and an Action Taken Report was then sought by the Commission through a letter dated 10.11.2016. In response a copy of the letter dated 30.11.2016, furnishing information to the Appellant was received in the Commission. The Appellant submitted another Complaint dated 18.12.2016 to the effect that the information furnished was not complete, and detailed the shortcomings pointwise.

From the deposition and the W/S, it is seen that certain information relating to departmental guidelines and order of constitution of a selection committee has not been furnished specifically and some information/documents have been described as “not available”. It emerged that the SPIO is in a position to comply with the aforementioned orders of the Commission in a more specific terms.

In view of the facts brought out above, the Commission hereby orders that the SPIO shall review the information furnished through a letter dated 30.11.2016 and furnish specific information where there has been lack of clarity as in case of departmental guidelines for selection of candidates for recruitment, constitution of selection committee for the overall selection process etc., free of cost, within 10 days of receipt of this order.

The Complaint case of non-compliance is disposed of with the above order.
