**O R D E R**  
03.03.2017

Shri Biman Dutta, SPIO/Deputy Secretary, Health & Family Welfare Department is present along with an assistant. He has submitted a Written Statement dated 27.02.2017.

The Appellant/Complainant is absent without information. However, the Commission decided to conduct the hearing proceedings *ex parte* of the Appellant considering the presence of the SPIO in the hearing and his submission of a W/S.

Perused the case record. It is seen that the Second Appeal was heard by the Commission and an order issued on 25.11.2016 requiring the SPIO to (a) furnish the information sought for and (b) explain as to why penalty should not be imposed. A copy of the Appellant's letter dated 21.12.2016 to the SPIO was received in the Commission which indicated that he was not satisfied with the action taken by the SPIO in compliance with the Commission's said order.

From perusal of the W/S and the deposition of the SPIO, it is seen that on receipt of the said letter from the Appellant, the SPIO furnished the appropriate information and invited the Appellant to visit his office and inspect records for verification. The SPIO further submitted that he had established contact with the Appellant by phone and ascertained that the latter had received the information and was satisfied with it.

In view of the facts brought out above, the Second Appeal case and the Complaint about non-compliance are hereby disposed of.
