The Appellant/Complainant, Shri Bijoy Kutum is present.

Heard the Appellant/Complainant. He submitted that the further information furnished to him by the SPIO through a letter dated 24.08.2016 was also incomplete.

Perused the W/S. Furnishing of information to the Appellant on 24.08.2016 subsequent to the Commission's last order has been mentioned.

The SPIO submitted that he had a set of the copies of the proceedings of the GP meetings for the period from 27.05.2011 to 23.06.2014 as sought for by the Appellant. The same was allowed to be handed over to the Appellant with a covering letter during the course of the hearing.

The Appellant acknowledged receipt of the set of documents. However, he requested to be allowed to inspect the documents in the office of the SPIO to which the SPIO agreed.

In view of the facts brought out above, the Commission hereby orders that the SPIO/Principal, J.D.S.G. College, Bokakhat, Golaghat shall allow inspection of the record in the office of the College within 15 days on a date to be fixed according to mutual convenience.

With this, the Complaint about non-compliance is hereby disposed of.
