The petitioner's representative Sri Seuj Bikash, Advocate is present.

The Public Authority is represented by Smt. Krishna Sarma, DGM/SPIO and Sri S.N. Ahmed, DGM (Law) / SPIO, office of the CGM (D), APDCL (LAR), Guwahati -1. The Public Authority stated that the information sought for by the petitioner has been furnished to him.

The representative of the petitioner present stated that copies of wages payment records which ascertain the engagement of the candidates mentioned continuously for three year under the Nalbari Electrical Sub-Division –I etc. prior to their selection for the post of Sahayaks and the copy of the initial engagement on daily wage, till their regular appointment as Sahayaks have not been furnished. The Public Authority present stated that experience certificates had been furnished by the office of the Rangia Electrical Circle which shows the period of service by the wage earners before appointment as Sahayaks. As regard initial engagement on daily wage, the Public Authority assured that SPIO, Rangia would be instructed to furnish the same.

Both the parties present stated that the case No. SIC/BGS. 6/2017 fixed for hearing today and case Nos. SIC/BGS.1/2017, SIC/BGS.3/2017, SIC/BGS.4/2017 fixed for hearing on 27.02.2017 are similar in nature, except the name of wage earners. As such order passed in case No. SIC/BGS.2/2017 will be applicable in all the cases mentioned above. The petitioner's representative present stated that he will be satisfied, if the dates of initial appointment of wage earners in the aforesaid cases are furnished to him.

In view of the above, the Commission directs the Public Authority to furnish the date of initial appointment of the wage earners in all the cases within 15 days from the date of receipt of this order. Copy of this order be kept in all the aforementioned files.

With the above, the second Appeal petition dtd.03.02.2017 is disposed of.
