The petitioner Shri Jiyaaur Rahman is present.

The Block Development Officer, Kalain Dev. Block, Cachar has informed that due to audit, he is unable to attend the hearing on 24.02.2017. Since huge numbers of cases are pending before the Commission, the matter is taken up for hearing *ex parte*.

On perusal of records, it appears that the petitioner Jiyaaur Rahman sought for information regarding details list of M.L.A. area development fund and BADP Scheme for the year 2011-12 to 2015-16 along with report on details of fund received and utilization. He also sought for details of various Schemes like B.R.G.F, T.F.C., 4th A.S.F.C, IAY house for the year 2011-12 to 2015-16 and list of raw materials and concrete Supplier etc. Due to non-receipt of information, he filed 1st Appeal petition before the Deputy Commissioner, Cachar, Silchar on 05.05.2016 which had not been heard or disposed of by the 1st Appellate Authority. The Appeal petition dtd. 08.08.2016 is therefore remanded to the 1st Appellate Authority for disposal with a speaking order after hearing both the parties within 21 days from the date of receipt of this order.

The petitioner shall be at liberty to move this Commission with second Appeal petition or complaint petition as the case may be, if he is aggrieved by the decision of the 1st Appellate Authority or because of non-disposal of the first Appeal petition by the 1st Appellate Authority.

With the above direction, the second Appeal dtd. 08.08.2016 is disposed of.
