The petitioner Shri Raktim Ranjan Saikia is present.

The Block Veterinary Officer, State Veterinary Dispensary, Kakojan, Jorhat has submitted a Written Statement dtd. 18.02.2017 that the information sought for by the petitioner was furnished to him through P & T Service. He was not aware that the petitioner had not received the reply as he was not contacted by the petitioner regarding non-receipt of information. He was informed by the District Officer, A.H. & Veterinary Department, Jorhat that the applicant had complained regarding non-receipt of reply and as such he forwarded a photocopy of earlier reply to the District Officer on 09.01.2017. He also stated that he did not have any financial power and as such he did not have any detail of fodder cultivation scheme.

On perusal of the records, it is seen that the petitioner filed RTI petition before the SPIO, Kakojan State Veterinary Dispensary on 26.10.2016. Due to non-receipt of information he had filed the 1st Appeal petition before the District. A. H & Veterinary Officer on 09.12.2016, but same had been transferred to the Veterinary Officer, State Veterinary Dispensary, Kakojan. It is seen that the 1st Appeal petition filed before the 1st Appellate Authority on 09.12.2016 has not been heard or disposed of by the 1st Appellate Authority. The Appeal petition dtd. 20.01.2017 is therefore remanded to the 1st Appellate Authority for disposal with a speaking order after hearing both the parties within 15 days from the date of receipt of this order.

With the above, the second Appeal petition dtd.20.01.2017 is disposed of.
