## ORDER 22.02.2017

The petitioner Shri Raktim Ranjan Saikia is present.

The Secretary, 30 No. Uttar Pachim Charigaon Gaon Panchayat, Jorhat has informed the Commission that the information sought for by the petitioner had been furnished to him on 02.01.2017 and part of the information remained to be furnished which had been handed over to the petitioner on 06.01.2017. He has enclosed a copy of receipt furnished by the petitioner.

The petitioner objected that he was not furnished the information on point No. 4, i.e. during the tenure of present President how much fund was distributed amongst how many beneficiaries towards repair of IAY house, the year of allotment each house including ID number of beneficiary along with name of block to which they belong and year of release for fund. He also stated that information on point No. 5 i.e. plantation scheme since 2007 till date of filing the RTI petition along with location, though furnished was illegible. He also stated that vide point No. 6 he had sought for the process of allotting IAY house to deserving beneficiary without ID number, whether Department or Deputy Commissioner, Jorhat issued any direction in this regard, if yes, to provide a certified copy of the same.

The Commission, therefore, directs the Secretary, 30 No. Uttar Pachim Charigaon Gaon Panchayat, Jorhat to furnish the information to the petitioner within 15 days from the date of receipt of this order.

With the above direction, the complaint petition dtd. 20.01.2017 is disposed of.
