**O R D E R**  
03.03.2017

The petitioner Shri Raktim Ranjan Saikia has submitted a Written Statement dtd. 03.03.2017 that he had filed an RTI petition on 09.09.2016 seeking for information from the Headmaster, Bahona Girls High School, Bahona, Jorhat. He filed 1<sup>st</sup> Appeal petition before the Inspector of Schools, Jorhat on 04.11.2016. Due to non-receipt of response from the SPIO and 1<sup>st</sup> Appellate Authority, he filed a complaint before the Commission on 21.12.2016. He also stated that the Headmaster, Bahona Girls High School, Bahona had sent information to him vide letter dtd. 25.02.2017, but the said information was incomplete as the information was sought for from 1<sup>st</sup> January, 2011 till 31<sup>st</sup> August, 2016. He has requested the Commission to direct the Headmaster, Bahona Girls High School, Bahona, Jorhat to furnish complete information. A copy of reply furnished by the Headmaster, Bahona Girls High School has been enclosed.

On perusal of reply enclosed, it is seen that the Headmaster, Bahona Girls High School, Bahona, Jorhat informed the petitioner that during his incumbency as Headmaster of Bahona Girls High School since 01.01.2013 to 03.03.2015, the accounts had been audited by the concerned authority and copy of the audit report had been sent to the petitioner along with information on expenditure for the year 2015-16 and information on point No. 3 & 4.

On perusal of case records, it is seen that the 1<sup>st</sup> Appeal filed by the petitioner before the 1<sup>st</sup> Appellate Authority on 04.11.2016 was not heard or disposed of by the 1<sup>st</sup> Appellate Authority. Since the matter also relates to the period before joining of the incumbent, the 1<sup>st</sup> Appeal petition dtd. 04.11.2016 is remanded to the 1<sup>st</sup> Appellate Authority for disposal with a speaking order after hearing both the parties within 21 days from the date of receipt of this order.

With the above, the complaint petition dtd. 21.12.2016 is disposed of.
