The petitioner Shri Sajall Singh is absent. However, he has sent a written communication dated 6th April, 2017 by e-mail stating that he could not attend today's hearing as he was out of station. He however, mentioned in his e-mail that he received some informations from the Addl. Deputy Commissioner, Kamrup (M) on 5.4.17 and is satisfied with the informations furnished against point nos. 8 (a), (b) & (d).
