O R D E R 19-4-2017

The petitioner Sri Bhaben Bhowmik is present. He is accompanied by Sri Suresh Ch. Biswas to assist him. The public authority is represented by :- (1) Sri Bidyut Bora, BDO of Mayong Development Block, Morigaon, (2) Sri Bikram Das, I/c Secretary, Burgaon G.P., and (3) Sri Marmeswar Deuri Sr. Assistant (Accounts) of the same office.

The second appeal petition dated 20-2-2017 is taken up for hearing in presence of both the parties.

From perusal of the case records it is seen that the petitioner filed an RTI petition dated 12-7-2016, which was not clearly drafted. In course of todays' hearing he clarified that he wants the following informations:-

- (1) Names of schemes with their locations, period of construction, estimate amount and actual expenditure against each scheme under MGNREGA,
- (2) List of beneficiaries of IAY houses with their addresses, estimated cost of each house and actual expenditure and period of construction of the IAY houses,
- (3) Copies of plan and estimates , sanction letters, work orders, photographs, Bank Statements , IAY Cash Book and expenditure vouchers.

The petitioner wanted the above informations in respect of 22 No.

Burgaon G.P under Mayong Development Block of Morigaon District for the period from 2012-2013 to 2016-2017.

From the above it appears that the informations sought for by the petitioner are voluminous in nature. The BDO and the Secretary of Buragaon G.P submitted that most of the informations sought for are already available in their Websites.

This Commission, therefore, directs the petitioner to first obtain the sought for informations from the Websites of 22 No. Buragaon G.P under MGNREGA and IAY Websites.

Thereafter, for that part of the informations which are not available in the Websites, he is directed to visit the office of the BDO, Mayong Development Block for inspection of relevant records during office hours within 20 days from the date of receipt of this order, which was pronounced in presence of both the parties and take notes and photocopies of documents.

The BDO of Mayong Development Block is directed to allow the petitioner to inspect the relevant records as above and also allow the petitioner to take notes and photocopies of documents, free of cost up to 50 copies and thereafter on payment of Rs. 2/- for every page of additional photo copy.

With the above order the second appeal petition dated 20-2-2017 is disposed of.
