**O R D E R**  
**7-4-2017**

The petitioner Sri Dulal Bora is absent. He informed the Registry of this Commission telephonically that he would not be able to appear before this Commission today due to other pre-occupations. The public authority is represented by :- (1) Sri Gobin Ch. Mili, SPIO of the office of Directorate of WPT&BC and (2) Sri Mohan Ch. Hazarika. of the same office.

The second appeal petition dated 2-3-2017 with reference to the petitioner's RTI petition dated 19-9-2017 seeking various informations about Tiwa Autonomous Council is taken up for hearing ex-parte in the absence of the petitioner.

The SPIO and Joint Director of the Directorate of WPT&BC made a written submission dated 1-4-2017 stating that the petitioner's RTI petition was transferred to the Principal Secretary of Tiwa Autonomous Council vide a letter dated 19-10-2017. Similarly the first appeal petition dated 2-1-2017 was also transferred to the Principal Secretary of Tiwa Autonomous Council vide letter dated 12-1-2017. The SPIO enclosed with his written statement , copies of his above mentioned letters addressed to the petitioner. He also mentioned that the Tiwa Autonomous Council is a Statutory Council established by the State Government and it is in existence.

From perusal of the RTI petition it is seen that the petitioner sought the following informations for the period 1<sup>st</sup> January, 2001 till 19-9-2016:-

- 1, ***Photocopies of utilization certificates, annual audit reports, Technical Committee's reports, Bank statements and cash books against all funds received from the Government.***
2. ***List of names of beneficiaries together with photocopies of documents submitted by each one of them for getting benefits of financial assistance and other materials and equipments like tractors, water filters, GPGC sheets, computers, sewing machines, Xerox machines , weaving looms etc, along with photocopy of permission of DIPR for such advertisements and***
3. ***Photocopies of advertisements of Notice inviting Tenders issued by DIPR through various media which were released through DIPR for purchase of various materials and equipments for distribution among the beneficiaries.***

It appears that the informations sought for will be voluminous and the scope is quite wide covering a period of **more than 15 years**.

This Commission, therefore, directs the Principal Secretary of Tiwa Autonomous Council to allow the petitioner to inspect all relevant office records within 15

days from the date of receipt of this order and also allow him to take notes as well as photo copies of documents sought for by him free of cost up to 50 copies and thereafter on payment of Rs. 2/- for every additional page of photocopy. Inspection of records should be done during office hours on any working day **within 15 days from the date of receipt of this order.**

With the above order the second appeal petition dated 2-3-2017 is disposed of.
