O R D E R 29-4-2017

The petitioner Sri Dulal Bora is absent. However, he has sent a written submission dated 3-4-2017 stating that due to his engagement in some other Court cases outside Guwahati, he was not able to attend the hearing before this Commission today. He has prayed for fixation of another date of hearing.

The public authority is represented by :- (1) Shri Akbar Ali, ARO and ASPIO of the Directorate of WPT&BC accompanied by Sri Mohon Ch. Hazarika, Sr. Assistant of the Directorate of WPT&BC.

The Chairman of Amri Karbi Autonomous Council is absent without any information.

The SPIO and Joint Director of WPT&BC has sent a written submission dated 21-3-2017 stating that the Amri Karbi Development Council is the holder of the information sought for by the petitioner vide his RTI petition dated 15-9-2016. Therefore his RTIO petition was transferred to the Chairman, Amri Karbi Development Council, GMC House No. 8, Old Cachal Path , Six Mile, Guwahati-22 vide letter dated 19-10-2016. Similarly, his first appeal petition dated 5-1-2017 was also transferred to the Chairman, Amri Karbi Development Council. There is nothing in the case records to show that the Amri Karbi Development Council has taken any steps to furnish the sought for information to the petitioner.

Fix **9-5-2017 at 1.30 P.M** for next hearing.

The SPIO of Amri Karbi Development Council is directed to be personally present on the next date of hearing and also to file an Affidavit detailing the actions taken by him on the RTI petition dated 19-9-2016 filed by the petitioner

If there is no SPIO then the Chairman of the Council shall be deemed to be the SPIO of the Development Council and he is directed to file Affidavit accordingly on or before the next date of hearing.

Also issue notice to all concerned for their personal appearance on the next date of hearing.

Attendance of the SPIO of the Directorate of WPT&BC is dispensed with as they are not the holder of the information and since they have already transferred the RTI petition to the Amri Karbi Development Council .
