The petitioner Sri Dulal Bora is absent. However , he has sent a written submission dated 3-4-2017 stating that due to his engagement in some other Court cases outside Guwahati, he was not able to attend the hearing before this Commission today. He has prayed for fixation of another date of hearing.

The SPIO and Joint Director of the Directorate of WPT&BC has sent a written submission dated 17-4-2017 stating that the Tiwa Autonomous Council is the holder of the information sought for by the petitioner vide his RTI petition dated 19-9-2016. Therefore, his RTI petition was transferred to the Principal Secretary, Tiwa Autonomous Council vide letter dated 19-10-2016. Similarly, his first appeal petition dated 2-1-2017 was also transferred to the Tiwa Autonomous Council. There is nothing in the case records to show that the Tiwa Autonomous Council has taken any action to furnish the sought for information to the petitioner.

Attendance of the SPIO of the Directorate of WPT&BC is dispensed with as they are not the holder of the information and since they have already transferred the RTI petition to the Tiwa Autonomous Council.
