**O R D E R****28-4-2017**

The petitioner Sri Dulal Bora is absent. However , he has sent a written submission dated 3-4-2017 stating that due to his engagement in some other Court cases outside Guwahati, he was not able to attend the hearing before this Commission today. He has prayed for fixation of another date of hearing.

The public authority is represented by :- (1) Sri Gobin Ch. Mili, Joint Director and SPIO of the Directorate of WPT&BC accompanied by Sri Mohon Ch. Hazarika, Sr. Assistant of the Directorate of WPT&BC (2) Sri Pradip Kr. Doley, Principal Secretary, Deori Autonomous Council, Narayanpur, District- Lakhimpur and (3) Sri Mridul Kr. Deori, Public Information Officer, Deori Autonomous Council, Narayanpur.

The Principal Secretary of Deori Autonomous Council , Narayanpur, P.O. Dikrong, District-Lakhimpur submitted orally that his substantive post is CEO, Zilla Parishad, Lakhimpur District. From December, 2016 he is holding the additional charge of the post of Principal Secretary, Deori Autonomous Council. He submitted that the Deori Autonomous Council came into existence from the year 2005 and not 2001 as stated by the petitioner in his RTI petition dated 19-9-2016. He further stated that the Directorate of Vigilance and Anti Corruption , Govt. of Assam seized all records of the Deori Autonomous Council for the period from 2005 to 2014-2015. At present the records for the financial year 2015-2016 is only available with the Deori Autonomous Council and he prayed for time to furnish the same to the petitioner. He stated that the petitioner has already been informed about the seizure of records by the Directorate of Vigilance and Anti Corruption.

In view of the above, the Principal Secretary of Deori Autonomous Council is directed to furnish the available information to the petitioner in response to his RTI petition dated 19-9-2016 within 15 days from the date of receipt of this order.

The matter will be taken up for hearing again at **1.30 P.M on 30<sup>th</sup> May, 2017**. The Principal Secretary is directed to submit his Affidavit on that day detailing the present position of records and action taken by him in response to the RTI petition dated 19-9-2016.

Issue Notice to (i) the SPIO of the Directorate of WPT&BC, (ii) the Principal Secretary, Deori Autonomous Council, and (iii) the petitioner accordingly for their presence on the next date of hearing.
