## ORDER

The second appeal petition dated 24.10.16 is taken up for hearing in presence of both the parties in pursuance of this Commission's earlier order dated 8.2.17.

This Commission , therefore, directs the Planning Officer of Inspectors of Schools, KDC(M) to provide copies of the relevant portions of both the reports to the petitioner with reference to the RTI petition dated 3.8.16 after taking due acknowledgment receipt today itself.

With the above order, the second appeal petition dated 24.10.16 is disposed of.
