**O R D E R**  
**25-5-2017**

1. The public authority to be represented by the SPIO of the office of Deputy Commissioner, Kamrup (Metro) District is absent. He has however, sent a written statement dated 22-5-2017 stating that today he is busy with the official visit of Hon'ble Prime Minister of India to Guwahati tomorrow dated 26-5-2017. He has prayed for fixation of another date of hearing. The petitioner/ appellant Sri Utpal Das also informed the Registry of this Commission, telephonically that he is also unable to attend the hearing today and prayed for postponement of the date of hearing after 30<sup>th</sup> May, 2017.

2. Earlier the SPIO and ADC, Kamrup Sri P. P. Katkhotia filed another written statement dated 19-5-2017 stating that the RTI petition was forwarded to Smti Barnali Sarma, ADC, Kamrup (Metro) and it was also transferred to the Commissioner, GMC, Kamrup (Metro). He also mentioned in the W.S that the first appeal petition dated 19-12-2016 was yet to be heard.

Later, District Development Commissioner Smti Barnali Sarma, ACS appeared before this Commission and made a written submission dated 25-5-2017, which was entered into the case records along with her written statement, she submitted a copy of her report dated 12<sup>th</sup> July, 2016 addressed to the Deputy Commissioner, Kamrup (Metro) on allegation regarding B .P. Chaliha swimming pool.

4. In view of the position stated at Para-1 above, fix **16-6-2017 at 1.30 P.M** for next hearing.

5 Issue notices to both the parties accordingly.
