### O R D E R 11-5-2017

1. The petitioner/ appellant Sri Dulal Bora is present. The public authorities are represented by :- (1) Smti Alaka Goswami, ACS, Joint Secretary and SPIO of WPT&BC Department, accompanied by Smti Purabi Das Kakoti, Sr. Administrative Assistant of the Department and (2) Sri Akbor Ali, ARO and ASPIO of the Directorate of WPT&BC accompanied by Sri Mohan Ch. Hazarika , Sr. Administrative Assistant of the Directorate.

- (b) **Steps taken for safe custody of the records of the dissolved Development Councils including Bishnupriya Manipuri Development Council ;**
- (c) **Present custodians of the records of the dissolved Development Councils; and ,**
- (d) **Particulars of the present SPIOs through whom a citizen can access admissible informations about the dissolved Development Councils**
