petitioner/ The appellant Sri Nagendra Nath Talukdar is 1. present

accompanied by Sri Dwijendra Nath Sarma to assist him. The public authority is represented by :- (1) Sri Chandan Kr. Bora, IFS, Deputy Conservator of Forests and SPIO of the office of PCCF (T), Lower Assam Zone, Panbazar, Guwahati-1, accompanied by Sri Himen Kr. Boro, Junior Asstt. of the same office.

2. The second appeal petition dated 31-10-2014 is taken up for further consideration in pursuance of this Commission's earlier order dated 16-8-2016.

The SPIO and DCF Sri Chandan Kr.Bora submitted orally that the 3 subject matter of this RTI petition, that is, the proposal submitted by the NGO called "Trinity" to the National Medicinal Plant Board (NMPB) and subsequent correspondence between State Medicinal Plant Board (SMPB) and NMPB is dealt with by the State Medicinal Plant Board and not in the office of PCCF (T). He further stated that the letter dated 24-12-2009 from NMPB was addressed to Sri Nagendra Nath Talukdar with a copy to the Secretary and Nodal Officer of SMPB, Assam. The Member Secretary and Nodal Officer of SMPB Assam informed the petitioner Sri Nagendra Nath Talukdar vide letter No. SMPB/Assam/RTI Act/235/2010/70 dated 19th October, 2012 about the latest status of the proposal which he submitted to NMPB. The appellant Sri Talukdar stated that he has not received the letter and that he will be satisfied if a copy of the same is given to him.

4. This Commission, therefore, directs its Registry to furnish a copy of the said letter dated 19th October, 2012 to the petitioner today itself, after obtaining acknowledgement for receipt of the same.

With the above order the second appeal petition dated 31-10-14 is 5. disposed of.
