The petitioner Shri A.K. Laskar is present.

The Public Authority to be represented by the BEEO, Lakhipur Block is absent without any intimation.

On perusal of the case records, the Commission observes that the information sought for by the petitioner vide his RTI petition dtd. 24.06.2014 involves a huge volume of information relating to several categories of information for several LP/UP Schools running in clusters of Binnakandighat, Dilkush, Binnakandi Bagan and Lakhipur Town under the BEEO, Lakhipur. Furnishing of complete information by making photocopy will definitely lead to huge burden on the resources of the concerned Public Authority.

The Commission therefore directs the petitioner to inspect relevant records and documents in the office of the BEEO, Lakhipur Block, Cachar within one month from the date of receipt of this order and complete inspection of documents during office hour within two working days. The petitioner will give two days prior notice to the Public Authority for inspection of documents.

The BEEO, Lakhipur Block, Cachar is directed to collect the records in respect of provincialization of LP/UP Schools from the Clusters of Binnakandighat, Dilkush, Binnakandi Bagan and Lakhipur Town under him and allow the petitioner to inspect the records & documents as above and allow him to take notes and photocopies of the sought for documents, free of cost, upto 15 copies and thereafter on payment of Rs. 2/- for every additional page of photocopy.
