## <u>O R D E R</u> 06.06.2017

Seen the action taken report submitted by the Joint Director, Health Service, Hailakandi before the Commission vide letter dtd. 02.03.2017 with copy to the petitioner Sri Dilwar Hussain Mazumder. He had stated that he had already informed the petitioner vide letter dtd. 07.11.2015 and 22.11.2015 that since the process of admission of ANM Training Programme has not been completed, information in details could not be disclosed. He also referred to the letter of Addl. Chief Medical and Health Officer, Hailakandi dtd. 28.02.2017 that the process of ANM Training Admission has not yet been completed, so the information in details could not be disclosed as desired and the information would be furnished later on with copy to the petitioner.

On perusal of the RTI petition, it is seen that the matter relates to admission to ANM Training Course of Govt. Nursing School dtd. 02.02.2015. The 1<sup>st</sup> Appeal petition filed by the petitioner before the 1<sup>st</sup> Appellate Authority i.e. Director of Health Service, Assam dtd. 13.11.2015 had not been heard or disposed of by the 1<sup>st</sup> Appellate Authority. The matter is therefore remanded to the 1<sup>st</sup> Appellate Authority i.e. Director of Health Services, Assam for hearing and disposal of the matter within one month from the date of receipt of this order.
