On perusal of case records, it appears that the petitioner Shri Longkiri Timung filed an RTI application dtd. 07.01.2017 before the SPIO, office of the Addl. Director of Agriculture(Hills), Diphu , Karbi Anglong seeking for information relating to appointment/promotion of Mr. Rajat Barman, Accountant of office of the Addl. Director of Agriculture (Hills), Diphu.

The Addl. Director of Agriculture (Hills), Diphu, Karbi Anglong vide letter dtd 13.01.2017 transferred the RTI petition to the District Agriculture Officer, Diphu, Karbi Anglong requesting him to furnish the information directly to the applicant within stipulated time under RTI Act, 2005.

The petitioner filed his 1st Appeal petition before the Addl. Director of Agriculture (Hills), Diphu, Karbi Anglong due to non-receipt of information from the SPIO, office of the Addl. Director of Agriculture (Hills), Diphu , Karbi Anglong which was again transferred to the District Agriculture Officer, Diphu, Karbi Anglong. The petitioner filed his 2nd Appeal petition before the Commission due to non-receipt of response from the District Agriculture Officer, Diphu, Karbi Anglong as well as 1st Appellate Authority.

The Commission therefore directs the District Agriculture Officer, Diphu, Karbi Anglong to furnish the information to the petitioner within 21 days from the date of receipt of this order.

With the above direction, the second Appeal petition dtd. 18.04.2017 is disposed of.
