Shri Rupeswar Chutia, Junior Engineer/SPIO, O/o the Chief Executive Officer, Karimganj Zilla Parishad and Shri Lokman Uddin, Senior Asstt. (Accounts) as deputed by the SPIO, O/o the Block Dev. Officer, South Karimganj Dev. Block present. They both submitted Written Statements dated 06.06.2017 and 08.06.2017.

The Appellant, Shri Sumen Roy is present. He submitted a W/S dated 09.06.2017.

Perused the W/S and heard the Appellant. He submitted that he has not received the information he had sought for through his RTI Application dated 13.11.2013 in over three and a half years.

Perused the W/S and heard the depute of the CEO, Karimganj Zilla Parishad to whom the First Appeal dated 07.03.2014 was forwarded. It has been submitted that the First Appeal was forwarded to the BDO, South Karimganj Dev. Block with a direction to provide the information within 7 days. The CEO wrote to the BDO once again on 04.04.2014 directing him to furnish the information within 3 days.

Perused the W/S of the BDO. The circumstances in which the information could not be furnished has been explained and time of another one month has been sought for furnishing the information/documents to the Appellant. The depute of the SPIO submitted that currently the BDO is himself the SPIO for his office.

In view of the facts brought out above, the Commission hereby orders that the SPIO/BDO, South Karimganj Dev. Block shall furnish the information sought for by the Appellant, free of cost, within 15 days of receipt of this order.

The Second Appeal is hereby disposed of.
