**O R D E R**  
08.06.2017

The Appellant, Shri Sumen Roy is present. He submitted a Written Statement dated 08.06.2017.

Shri Bishwa Ranjan Bhowmik, Junior Asstt./ASPIO, Hailakandi Zilla Parishad present. He submitted a Written Statement dated 08.06.2017, a copy of the letter written to the SPIO, O/o the Commissioner, Panchayat & Rural Dev., Assam transferring point number 2 of the RTI Application and letter authorizing him to attend the hearing.

Heard the Appellant and perused his W/S. It has been submitted that the information received by him was 'misleading and incorrect'.

Heard the ASPIO and perused his W/S. The action taken to furnish the information and transfer the aforementioned part of the RTI Application has been indicated along with copies of the communication made to the Appellant and the copies of documents given to him.

From the personal deposition and perusal of the written submission, it emerged that the information given in respect of point number 1 is not fully appropriate, the information relating to the point number 2 ought to be possible to be furnished by the SPIO and the information on the remaining points are in order.

Considering the facts brought out above, the Commission hereby orders that the SPIO shall review the information furnished in respect of point number 1 and furnish appropriate information as available on record regarding provisions for engagement of contractors in P & RD work and recheck the records of the office and furnish the information sought for relating to Amendment to the Panchayati Act to enable engagement of contractors within 10 days of receipt of this order including that on point number 2.

The Second Appeal is hereby disposed of.
