The Appellant, Shri Mati Ram Nath is present.

Heard the Appellant. He submitted that he had not received the information he had sought for through his RTI Application dated 18.02.2017.

Heard the depute of the Project Director, DRDA, Darrang, Mangaldai. The First Appeal dated 24.03.2017 was disposed of on 12.04.2017 with the direction to Shri Manoj Bania, Programme Officer/SPIO, O/o the Kalaigaon Dev. Block to provide the information to the Appellant before 21.04.2017.

It is evident that the said SPIO did not comply with the direction.

Heard the Secretary of the said G.P. He was unable to inform as to why the SPIO, O/o the BDO, Kalaigaon Dev. Block did not furnish the information.

The Second Appeal is hereby disposed of with the direction to the Block Dev. Officer, Kalaigaon Dev. Block to furnish the information to the Appellant, free of cost, within 10 days of receipt of this order. However, the Appellant shall be at liberty to move this Commission, if he is aggrieved by the response of the SPIO.
