O R D E R 14.07.2017

Shri Pradip Kr. Bhattacharjya, P.S.O., O/o the Inspector of Schools, Nalbari as deputed by the Inspector of Schools, Nalbari and Shri Askar Ali Ahmed, Principal, Mugdi Milan H.S. School are present.

The Appellant, Md. Chandmahammad Pradhani is present.

Heard the Appellant. He submitted that out of the eight schools in respect of which he had sought information, he has received information excepting from Mugdi Milan H.S. School, Char Anchalik H.S. School and Bartala High School. The Principals of the latter two schools are not present in the hearing.

Heard the deputee of the Inspector of Schools, Nalbari and the Principal, Mugdi Milan H.S. School. A Written Statement dated 12.07.2017 from the Inspector of Schools, Nalbari has been submitted.

The Principal, Mugdi Milan H.S. School explained the reason for the delay stating that he had taken over charge recently and his predecessor had been ill for months. He assured to furnish the information now. The deputee of the Inspector of Schools, Nalbari submitted that he had not been able to contact the Principal, Char Anchalk H.S. School, possibly because of the ongoing floods.

From the personal deposition and perusal of the Written Statement, it is seen that the Principal, Bartala High School had requested the Appellant to deposit the cost of photocopying. The Appellant stated that the said Principal had assured furnishing of the information when he had met him.

Considering the facts brought out above, the Commission hereby orders that the Principals of the aforementioned Schools, namely Mugdi Milan H.S. School, Char Anchalik H.S. School and Bartala High School shall furnish the information to the Appellant, within 15 days of receipt of this order.

The Second Appeal is hereby disposed of.
