Dr. Prasanta Barman, Deputy Registrar and PIO, Gauhati University is present along with an assistant. He submitted a Written Statement dated 12.07.2017.

The Complainant absent without information.

Heard the SPIO and perused the Written Statement. The RTI Application dated 02.01.2017 was transferred to the Principal, Jagiroad College, PO:Jagiroad, District: Morigaon, Assam as the information sought for related to that Public Authority through a letter dated 28.01.2017. The copy of the said letter enclosed with the Written Statement indicates that the Applicant was not informed about the transfer of his Application.

Perusal of the case record indicates that the Complainant had submitted his Complaint dated 06.03.2017 stating that the SPIO did not furnish the information within the stipulated time.

It is evident from the above, that the Complainant would not have complained against the said SPIO if he was kept informed of the transfer. It is also evident that the Complainant did not receive the information from the SPIO of the said college by the date of his Complaint.

The SPIO/Principal of the said college was not notified about today's hearing as the fact of the transfer of the Application of the case was not brought to the notice of the Commission.

Fix next date of hearing in 5 weeks' time and notify the SPIO/Principal, Jagiroad College and the Complainant.
