## O R D E R 24-7-2017

- 1. The petitioner/ appellant Sri Jugal Kishore Chopra is present accompanied by his son Sri Rajesh Chopra.. The public authority to be represented by the SPIO of the office of the Directorate of Health Services, Assam, Hengrabari, Guwahati-36 is absent without any information.
- In its previous order dated 1-6-2017 the SPIO of the Directorate of Health Services was directed to furnish the names of the CMHO and M&HOs (In charge) posted during 1988 to 1993 in the districts mentioned by the petitioner at point No. (ii) of his RTI petition within 30 days from the date of receipt of the order. Similar direction was issued in respect of point No.. (iii) of the petitioner's RTI petition dated 25-3-2015 also. No compliance report has been received from the SPIO of the Directorate of Health Services till today. *This Commission views this lapse seriously.* The SPIO of the Directorate of Health Services is, therefore, directed to submit a compliance report on or before 11-8-2017. Issue notices to the SPIO and the appellant for their personal appearance on the next date of hearing i.e. 11-8-2017, 12 Noon. Since the matter has been badly delayed *issue notices also to the Director of Health Services and the concerned officer, not below the rank of Joint Secretary to the Govt. of Assam, Health & F.W Department dealing with matters mentioned in point No. (ii) and (iii) of the RTI petition dated 25-3-2015. Issue notices to them also enclosing copies of the RTI petition.*
