1. The petitioner/ appellant Sri Dulal Bora is present. The public authority is represented by Sri :Prasanta Borkakati, SPIO and Deputy Secretary, Personnel (A) Department accompanied by Sri Ankur Sarma, Junior Administrative Assistant of the Department to assist him.

2. The SPIO and Deputy Secretary, Personnel (A) Department submitted a written statement dated 27th July, 2017 stating that seven (7) RTI petitions all dated 6-12-2016 pertaining to the following second appeal cases:-
