**O R D E R**  
**7-7-2017**

1. The petitioner/ appellant Sri Anmol Sing Chauhan is present accompanied by one Sri Sangram Sing Chauhan to assist him. The public authority is represented by :- (1) Sri Dhiraj Baishya, SPIO, Planning & Statistical Officer, Office of the Inspector of Schools, MDC, Morigaon, (2) Sri Abbas Ali, Jr. Assistant
2. The second appeal petition dated 13-2-2017 , as re-submitted on 20-5-2017 after rectifying the infirmities in the earlier second appeal petition is taken up for hearing in presence of both the parties.
3. The SPIO of the Inspector of Schools , MDC, Morigaon has submitted a written statement dated 6<sup>th</sup> July2017, which is entered into the case records.
4. On perusal of the case records it is seen that the petitioner filed an RTI petition dated 5-12-2016 before the Director of Secondary Education, Assam seeking certain informations like the list of teachers and copies of their appointment letters and educational qualifications of Kuhtoli Borongone H. S School, Post Office – Borongoni, PIN-782 127, District- Morigaon, Assam. The Officials of Education Department present submitted that Kuhtoli Borongoni H. S School which is a venture school, has not yet been given any permission to impart any education in the Higher Secondary section .
5. When asked , the petitioner also stated orally that they have applied for permission to run the Higher Secondary classes, which is awaited.
6. In view of the above, the resubmitted second appeal petition dated 20-5-2017 is disposed of.
