O R D E R
6-7-2017

1. The petitioner/ appellant Sri Gopal Prasad Gupta is present. The public authority to be represented by the SPIO of the office of Asom Anushuchita Jati Parishad/ Mahanagar Zilla Anusuchita Jati Parishad, Uzanbazar, Guwahati is absent without information.

2. From perusal of the case records, it is seen that the petitioner filed an RTI petition dated 23-8-2016 to the "In charge of the office" of the Asom Anushuchita Jati Parishad/ Mahanagar Zilla Anusuchita Jati Parishad, Uzanbazar, Guwahati, followed by first appeal petition dated 3-1-2017 filed before the office of the President/ General Secretary, Asom Anushuchita Jati Parishad/ Mahanagar Zilla Anusuchita Jati Parishad, accompanied by a separate petition for condonation of the delay in filing the first appeal petition. The petitioner did not receive any response from the First Appellate Authority to his delayed first appeal petition and prayer for condonation of the delay. Thereafter he filed a second appeal petition dated 5-5-2017 before this Commission.

3. This Commission is of the view that against the above mentioned background, it would be premature to hear the second appeal petition. Therefore, the First Appellate Authority of Asom Anushuchita Jati Parishad is directed to dispose of the first appeal petition as well as the prayer for condonation of the delay in filing the first appeal petition by the petitioner by a speaking order within thirty days from the date of receipt of this order.

4. With the above order the second appeal petition dated 5-5-2017 is disposed of.
