## ORDER 4-7-2017

- The petitioner/ appellant Sri Dulal Bora is present. The public authority, 1. i.e., the Deori Autonomous Council is represented by Sri Mridul Kr. Deori, Assistatnt Engineer and SPIO of Deori Autonomous Council (DAC), as authorized by the Principal Secretary, Deori Autonomous Council vide his letter Dated 1st July, 2017, copy of which has also been given to the Registrar of this Commission.
- 2. The Principal Secretary, Deori Autonomous Council Sri Pradip Kr.Doley has sent a written statement dated 1st July, 2017 with several enclosures stating the present position about : .- (a) records of DAC, (b) information already furnished to the Commission and (c) copy of seizure list furnished by the Vigilance and Anti Corruption, Assam. His written statement is entered into the case records.
- 3. It is seen from the written statement and enclosed papers that :-
  - (a) DAC was established in the Financial Year 2005-2006. Therefore, the question of furnishing any information before the Autonomous Council came into existence does not arise;
  - (b) Relevant records pertaining to the period from 2005-2014-2015 have been seized by the Vigilance and Anti Corruption vide seizure list mentioned at Annexure-2. Therefore, information for that period cannot be provided.
  - (c) Information for the Financial Year 2015-2016 have already been furnished to the petitioner, who has acknowledged receipt of the same.
- The Assistant Engineer representing the DAC who is present today made a separate written statement reiterating the submissions already made by the Principal Secretary of DAC.
- The petitioner however, submitted that while appreciating 5. the

position stated by the Principal Secretary, DAC, he sought the leave of this Commission to submit a list of important informations covering all the 8 pending second appeal petitions which may still be available with the DAC.

- This Commission grants the petitioner permission to submit the list proposed by him within seven (7) days from the date of this order for sending it to the SPIO of DAC to furnish the available informations to the petitioner against each point, and if informations against any document is not available or cannot be furnished then to explain the reasons therefore to the petitioner within thirty (30) days from the date of receipt of the list of informations sought for by the petitioner, as above, from the Registry of this Commission.
- 7. The petitioner is also directed to specify the informations and documents as is required under Section 6(1).
- 8. Put up on <u>4-9-2017 at 12.00 Noon</u> for review of compliance position.
- 9. The above order shall be applicable *Mutatis Mutandis* to all the eight (8) cases , i.e., SIC/KP(M).62/2017/ SIC/KP(M).97/2017 / SC(KP(M) 96/2017 / SIC/KP(M).94/2017 / SIC/KP(M).95/2017 / SIC/KP(M).61/2017 / SIC/KP(M).98/2017
