**O R D E R**

**6-7-2017**

1. The petitioner/ appellant Sri Nitumoni Deka is present accompanied by Sri Pulak Barman, Advocate. The public authority is represented by (1) Sri Chagendra Nath Kakoty, Inspector & SPIO of the office of Assistant Director, Handloom and Textiles, accompanied by Sri Khagen Ch. Nath, Suptdt. Handloom Production Centre, (HPC), Jagori, Nagaon and Cluster Development Executive, Sualkuchi (East) Cluster.

2. The complaint petition dated 22-5-2017 is taken up for hearing in presence of both the parties. When asked by this Commission, the petitioner stated that he is still interested in getting the informations sought for vide his RTI petition dated 20-1-2017 and he filed a written submission dated 6-7-2017, praying for conversion of his complaint petition dated 22-5-2017 into a second appeal petition under Section 19 of the RTI Act, 2005. His prayer is granted and the complaint petition is taken up for hearing as a second appeal petition, in presence of both the parties.

3. The SPIO of the office of the Assistant Director, Handloom and Textiles, Kamrup, Guwahati submitted a written statement dated 30<sup>th</sup> June, 2017 stating that the sought for informations were also submitted to a group of persons led by one Sri Dhruba Jyoti Sarma on 11-1-2017. The present petitioner Sri Nitumoni Deka was also a member of the group. Thereafter Sri Bipul Das, a member of the Sualkuchi (East) Cluster and I/C of Yarn Depot was demanded money by some extremists and Sri Bipul Das lodged an FIR with the Sualkuchi Police Station vide Police case No. 33/2017

under Section 341/385/506 IPC. It has been stated in the W/S that since the subject matter of the RTI petition became sub-judice in the above mentioned Police case, therefore, under Section 8(1)(g and h) of the RTI Act, 2005 the sought for informations were treated as exempted and not furnished to the present petitioner, separately.

4. This Commission is of the view that the informations sought for by the present petitioner vide his RTI petition dated 20-1-2017 should in any case have been disclosed suo motu by the concerned public authority under Section 4 (1)(b). Moreover, the informations sought for are *post facto*. They do not seem to have any relationship with the Police case mentioned above.

5. In view of the above, the SPIO of the office of Assistant Director, Handloom and Textiles is directed to furnish the sought for informations , year-wise to the petitioner within 30 days from the date of receipt of this order.

6. With the above order the complaint petition dated 22-5-2017 is disposed of.
