A Written Statement dated 02.08.2017 has been submitted by the BDO, South Karimganj Dev. Block.

The Appellant, Shri Abdur Rouf Tapadar is present along with an assistant.

Perused the case record. The Second Appeal was heard by the Commission and issued orders on 21.02.2017 and 12.05.2017. It was ordered that the SPIO should review the information already furnished to the Appellant and furnish additional information, if any, in accordance with the RTI Application, and allow the Appellant to inspect records in respect of the rest of the points of the Application which involve voluminous records. The hearing on 12.05.2017 was in connection with the Complaint of non-compliance. As neither party was present, it was decided to fix another date for hearing. Hence, today's hearing.

Heard the deputee of the BDO. It was submitted that Commission's order dated 21.02.2017 was received only with the hearing notice for today and immediate action was taken to furnish the information including copies of documents related to the third and fourth points instead of inviting the Appellant to inspect the records. A copy of the said letter dated 25.07.2017 sent by Registered Post has been enclosed with the Written Statement. He added that he had carried another set of documents which could be handed over to the Appellant, should he desire.

Heard the Appellant. He submitted that he had not received the said letter.

The deputee of the BDO was allowed to hand over a copy of the said letter along with the enclosures during the hearing.

Considering that the Appellant has received the information, the Complaint of noncompliance is hereby disposed of.
