Both parties absent.

A Written Statement with today's date 05.08.2017 jointly signed by the SPIO and the Principal, JDSG College, Bokakhat has been received. A Written Statement has also been received from the Appellant by e-mail today.

Perused the Written Statement of the Appellant. He has sent an apology for today's hearing on account of a reported bandh in the state. He has requested to fix another date for hearing. However, he has submitted that he received some information yesterday evening in the form of photocopies, but two crucial pieces of information were stated by the college authorities to be not available in the college. He added that that information was very important to prove corruption in the use of UGC funds in the college.

Perused the Written Statement of the Principal. It is seen that the information had been handed over yesterday to, the Appellant and its receipt acknowledged. A copy of the acknowledgement letter has been enclosed. However, perusal of the enclosures indicates that the Appellant has not received the entire set of documents as sought for by him. He stated that while documents were informed to be available in the college by the Principal, these were not actually supplied yesterday. Utilization Certificates of the Remedial Coaching grant was not available in the college office and the UC of B.Com course was not submitted to UGC.

Considering the plea of the Appellant that the information provided was not complete and that he has requested for deferment of today's hearing, the Commission decided to fix another date of hearing. However, the Commission hereby directs the SPIO, O/o the Principal, JDSG College meanwhile to review the information already furnished to the Appellant and furnish the remaining information/documents, free of cost, within 15 days of receipt of this order.

Post next hearing on 22.09.2017 at 11:30 AM.

However, no hearing shall be necessary, if appropriate action is taken in the meantime to furnish all the information/documents to the Appellant, and the latter reports his satisfaction to the Commission in the meantime.
