O R D E R

1. The appellant Sri Manabendra Lahkar is present. The public authority to be represented by the SPIO of the office of the Deputy Commissioner, Kamrup (Amingaon) and the Circle Officer, Rangiya Revenue Circle, District- Kamrup are absent. However, they have sent two separate written submissions, both dated 31-7-2017 , which are entered into the case records.
2. On perusal of the case records it is seen that the petitioner filed two (2) separate RTI applications dated 16-2-2016 and 27-9-2016, The petitioner made a written submission stating that he has meanwhile received the sought for informations in response to the RTI petition dated 16-2-2016 to his satisfaction. Therefore, it appears that there is no further cause of action on this. However, with regard to the RTI petition dated 27-9-2016 the petitioner submitted that he is not satisfied with the informations furnished on the ground that according to alternative informations available with him, the informations furnished by the Circle Officer, copy of which was also furnished to him by the Addl. Deputy Commissioner of Kamrup District vide letter dated 13-10-2016 are not correct.
3. In view of the above, it is considered necessary to compare the alternative set of informations and documents available with the applicant, Sri Manabendra Lahkar with all the relevant original records available with the Circle Officer of Rangiya Revenue Circle, including village map, Chitha , Jamabandi etc.
4. Therefore, fix **25-8-2017, 12.30 P.M** for next hearing. Issue notices to both the parties ie., SPIO of the office of Deputy Commissioner, Kamrup (Amingaon) and Circle Officer, Rangiya Revenue Circle as respondents to appear with all relevant records and also Sri Manabendra Lahkar the applicant.
