<u>O R D E R</u> 07-9-2017

- 1. The appellant/petitioner Sri Swapan Barman is present. The public authority to be represented by the SPIO of the office of the Deputy Commissoner, Kamrup (Metro) and the Circle Officer, Dispur Revenue Circle are absent. The Circle Officer, Dispur Revenue Circle deputed an Assistant from his office to report that the Circle Office had an eye surgery and therefore, he is not in a position to attend todays' hearing. Through his messenger he has requested for re-fixation of the date of hearing. The SPIO of the office of Deputy Commissioner, Kamrup (Metro) has also sent a separate prayer dated 1-9-2017.
- 2. The SPIO of the office of Deputy Commissioner , Kamrup (Metro) has also sent a written submission dated 1-9-2017 stating that the SPIO of the office of Deputy Commissioner, Kamrup (Metro) had furnished the sought for informations to the petitioner vide letter No. RTI.25/2016/17/1020 dated 12-7-2016. Subsequently the first appeal petition was also heard by the FAA on 29-11-2016 and an order was passed directing the Circle Officer, Dispur Revenue Circle to furnish the information within 15 days from the date of receipt of FAA's order. However, the petitioner was not satisfied with the information furnished by the Circle Officer , Dispur Revenue Circle vide his letter dated 3-3-2017 leading to the second appeal petition dated 30-5-2017
- 3. Fix 11-10-2017 1.30 P.M for next hearing. Issue notice to all concerned accordingly for their personal attendance.
