## O R D E R 24-8-2017

- The appellant/petitioner Sri Diganta Barman is present. The public authority is represented by Sri Jitendra Mazumdar, Fatasil Electrical Subdivision, Ambari.
- The second appeal petition dated 5-7-2017 is taken up for consideration in presence of both the parties. The First Appellate Authority i.e., Chief General Manager, APDCL, (LAR) has submitted a written submission dated 22-8-2017 which is entered into the case records.
- From perusal of the case records, it is seen that the petitioner filed an RTI petition dated 13-10-2016 before the PIO of ASEB, Bijulee Bhavan, Paltanbazar, Guwahati-8 which was transferred to the Manager, Fatasil Electrical Subdivision vide letter dated 27-10-2016.
- 4. Not getting any response from the concerned public authority, the petitioner filed his second appeal petition dated 5-7-2017 together with a separate prayer for condonation of the delay as he had to go to Chennai for treatment. His prayer for condonation is granted.
- 5. The petitioner submitted that he has meanwhile received all other informations sought for by him except copies of affidavit and Indemnity Bond which the consumer Sri P. K. Das furnished at the time of applying for electrical connection in his residence.
- 6. The petitioner submitted orally that he needs those two documents to take legal actions against Sri P. K. Das who has unauthorizedly occupied the petitioner's land and built a house there to which he has been given electricity connection by the APDCL.
- 7. The Subdivisional Engineer, Fatasil Electrical subdivision submitted that while they could trace out the other sought for informations, the affidavit and the Indemnity Bond could not be traced out, they being old records dating back to the year 2007. He prayed for sufficient' time to trace them out from the office record room or to obtain those two documents from the consumer by serving notice on him.

His prayer is granted. Fix 11-10-2017, 12.30 P.M for next hearing and review of action taken.
