**O R D E R**  
**4-8-2017**

1. The petitioner/appellant Sri Joydeb Das is present. The public authority is represented by :- (1) Sri Pradip Ch. Buragohain, SPIO and General Manager (F&P), Assam Seeds Corporation Ltd., Khanapara accompanied by Sri Gunjanan W.Shyam, ASPIO , of the same office.
2. The second appeal petition dated 17-7-2017 is taken up for hearing in presence of both the parties.
3. From perusal of the case records, it is seen that the second appeal petition involves twelve Nos of RTI petitions, all of which are dated 11-4-2017. Out of these 12 (twelve) RTI applications, the first 11 (eleven) applications were filed seeking the same informations from Assam Seeds Corporation Ltd. , although the names of the vendors and names of the seeds are different. The informations sought for by the 12<sup>th</sup> RTI application, but are substantially different.
4. As regards the first eleven (11) RTI applications the SPIO of ASCL handed over the sought for informations to the petitioner before this Commission. Therefore, there is no cause of action with regard to these eleven RTI petitions.
5. As regards the 12<sup>th</sup> RTI application also the SPIO submitted that due to some mechanical problems with the Xerox machine, the required information could not be furnished to the petitioner within the stipulated time. He assured this Commission that he will be able to furnish the sought for information to the petitioner within seven (7) days from today. The petitioner also accepted the assurance.
6. In view of the above the second appeal petition dated 17-07-2017 is disposed of.
