The petitioner Shri Bhupat Kalita is present accompanied by Shri Rabindra Tamuli to assist him. The public authority is represented by the SPIO and Staff Officer in the office of the Chief Secretary to the Govt. of Assam. The second appeal petition dated 9.8.17 is taken up for hearing in presence of both the parties.

It is seen from the case records that the petitioner filed an RTI petition dated 12.5.17 before the Chief Secretary to the Govt. of Assam seeking various informations about use of Government vehicles by public servants for private use. The RTI petition was transferred vide letter dated 17.5.17 to the Joint Secretary & SPIO of Transport Department, Govt. of Assam with copy to Shri Bhupati Kalita, the petitioner. Thereafter, the Joint secretary, Transport Department, Govt. of Assam vide a letter dated 30.5.17 furnished the required informations to the petitioner. The petitioner, however, submitted orally that he did not receive copy of the letter dated 17.5.17 transferring RTI application and the letter dated 30.5.17 from the Joint Secretary, Transport Department, Govt. of Assam furnishing informations.

The SPIO of Chief Secretary's office submitted a copy of letter dated 30.5.17 before the Commission. The Registry of this Commission is directed to furnish a copy of informations furnished vide letter dated 30.5.17 to the petitioner by hand today and obtain receipt of acknowledgment from him.

With the above, the second appeal petition dated 9.8.17 is disposed of.
