**O R D E R**  
**18-9-2017**

1. The matter is taken up for review of compliance of this Commission's order dated 31-7-2017 by the SPIO of Sonowal Kachari Autonomous Council
2. The Assistant PIO of Sonowal Kachari Autonomous Council has submitted a copy of this letter dated 22-8-2017 addressed to Sri Amrit Bora, the petitioner, enclosing the copies of informations furnished by him in respect of point No.-5 of the RTI petition dated 30-7-2014 in compliance with this Commission's order dated 31-7-2017.
3. The petitioner Sri Amrit Bora is absent. No further complaint or prayer has also been received from him. So it is presumed that he has received the informations furnished to him to his satisfaction. Therefore, the matter of furnishing of information is treated as closed.
4. By this Commission's order dated 31-7-2017, the SPIO of Sonowal Kachari Autonomous Council was directed to submit his written explanation on or before 31-8-2017 as to why penalty under Section 20(i) of the RTI Act, 2005 shall not be imposed on him for his failure to furnish the information within the stipulated time. It was clearly mentioned in this Commission's order dated 31-7-2017 that this Commission would take suo motu ex-parte decision, if the SPIO fails to submit his written explanation by 31-8-2017. No written submission have been received from him till date.
5. However, it is decided to give a reasonable opportunity of being heard before any penalty is imposed on him
6. **Fix 30-10-2017,1.30 P.M for his personal hearing. Issue notice to him accordingly.**
